

**SECOND AMENDMENT TO COUNTY OF MENDOCINO  
BOARD OF SUPERVISORS AGREEMENT NO. BOS-22-182**

This second Amendment to Board of Supervisors (BOS) Agreement No. BOS-22-182 is entered into this 18th day of July, 2023, by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Redwood Community Services, Inc.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. BOS-22-182 was entered into on July 1, 2022; and

WHEREAS, first Amendment Agreement No. SS-22-084 was entered into on December 20, 2022; and

WHEREAS, upon execution of this document by the County of Mendocino and the CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to extend the termination date set out in the original BOS Agreement No. BOS-22-182, from June 30, 2023 to June 30, 2024.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. BOS-22-182 is hereby extended from June 30, 2023 to June 30, 2024.

All other terms and conditions of BOS Agreement No. BOS-22-182, and first Amendment Agreement No. SS-22-084 shall remain in full force and effect.
