FIRST AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. BOS-22-243

This Amendment to BOS Agreement No. <u>BOS 22-243</u> is entered into this 26th day of September 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>SIMPLER SYSTEMS</u>, <u>INC.</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. BOS 22-243 was entered into on October 04, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>BOS 22-243</u>, from <u>September 30, 2023</u>, to <u>September 30, 2024</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No. <u>BOS 22-243</u>, by \$18,000.00, for the continued need for services, for a new total contract amount of \$88,000.00

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>BOS 22-243</u> will be extended from <u>September 30, 2023</u>, to <u>September 30, 2024</u>.
- 2. The total contract amount set out in Agreement No. <u>BOS 22-243</u> will be increased by \$18,000.00 for a new total contract amount of \$88,000.00

All other terms and conditions of BOS Agreement No. <u>BOS 22-243</u> shall remain in full force and effect.
