

**RESOLUTION NO. 26-064**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS ESTABLISHING THE TOTAL MILEAGE OF COUNTY MAINTAINED ROADS AT 1,016.61 AS OF DECEMBER 31, 2025 (COUNTY WIDE)**

WHEREAS, Section 2121 of the California Streets and Highways Code provides that in May of each year, each county shall submit to the California Department of Transportation (Caltrans) any additions to, or deletions from, its mileage of county-maintained roads, specifying the termini and mileage of each route added or excluded; and

WHEREAS, Caltrans certified to the State Controller by July 1, 2025, that the total mileage of County Maintained Roads in Mendocino County was 1,017.12 miles as of December 31, 2024; and

WHEREAS, a total length of 0.32 miles was vacated from Rockport Street, County Road (CR) 429A, and 0.19 miles was vacated from the end of Wilderness Lodge Road, CR 320, which resulted in an overall decrease of 0.51 miles in the total mileage of County Maintained Roads during the year ending in December 31, 2025.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby establishes the total mileage of County Maintained Roads, as of December 31, 2025, to be 1,016.61 miles, and authorizes the Department of Transportation to transmit this Resolution to Caltrans.
