

**SECOND AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. BOS #21-139**

This Amendment to BOS Agreement No. BOS #21-139 is entered into this 5th day of December 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and NOKIA OF AMERICA CORPORATION, hereinafter referred to as "CONTRACTOR".
