

**AMENDMENT TO COUNTY OF MENDOCINO  
PURCHASING AGENT AGREEMENT NO. 20-154**

This Amendment to Agreement No. PA 20-154 is entered into this 6th day of June, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Anker-Lucier Mortuary, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 20-154 was entered into on July 14, 2020; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. PA 20-154, from June 30, 2023 to June 30, 2024; and

WHEREAS, Agreement No. PA 20-154 provided for an option to extend the Agreement for up to two (2) consecutive one (1) year periods; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No. PA 20-154 by \$16,666.66 for a new total contract amount of \$66,666.66.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original Agreement No. PA 20-154 will be extended from June 30, 2023 to June 30, 2024.
2. The amount set out in Agreement No. PA 20-154 will be increased by \$16,666.66, the maximum amount of the first one-year extension.
3. The Payment Terms, Exhibit B, Item No. 3 set out in original Agreement No. PA 20-154 has been altered and a new Payment Terms, Exhibit B is attached herein with changes denoted in bold font.

All other terms and conditions of Agreement No. PA 20-154 shall remain in full force and effect.

### PAYMENT TERMS

A. COUNTY shall pay CONTRACTOR per the following instructions:

2. COUNTY will pay CONTRACTOR for Coroner-related mortuary services as follows:

Removal of remains within response area	\$0.00
Storage of remains beyond (7) days	\$35.00 per day
Storage of remains up to (7) days	\$0.00
Special Transportation of remains within 10 miles of mortuary (example-Hospital X-Rays)	\$0.00
Special Transportation of remains over 10 miles or to mortuary in Ukiah for examination	\$200.00 per case
Standby time in excess of 1 hour	\$60.00 per hour

3. **Payments under this Agreement shall not exceed Sixty-Six Thousand Six Hundred Sixty-Six Dollars and Sixty-Six Cents (\$66,666.66) for the term of this Agreement.**
