

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 22-211**

This Amendment to BOS Agreement No. 22-211 is entered into this 11th day of July, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and CENTRAL SQUARE TECHNOLOGIES, LLC, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 22-211, was entered into on August 16, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CENTRAL SQUARE TECHNOLOGIES, LLC, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to amend the original BOS Agreement No. 22-211, to eliminate automatic renewals and provide the agreement with a specific three-year term, and specify the amounts paid for each fiscal year under the agreement.

NOW, THEREFORE, we agree as follows:

1. Section 2.1 is amended to read as follows:
"Term. The Term of this Agreement commences July 1, 2021, and will continue in effect until June 30, 2024, unless terminated earlier pursuant to any of the Agreement's express provisions (the "Term")."
2. Sections 2.2 and 2.3 are hereby deleted.
3. The total compensation set out in the original BOS Agreement No. 22-211 will be increased from \$88,617.99 (\$43,228.29 for FY 2021/2022 and \$45,389.70 for FY 2022/2023) to \$138,546.66 (for FY 2023/2024).
4. Clause b. of the "Software Maintenance/Renewal Fees" Section of Exhibit 1 – Project Cost Summary is hereby amended to read as follows:
 - b. Maintenance/Renewal fees for July 1, 2022, through June 30, 2023, and for July 1, 2023, through June 30, 2024, will be invoiced subsequently as follows and due within thirty (30) days from date of invoice:
 1. July 1, 2022, through June 30, 2023: \$45,389.70
 2. July 1, 2023, through June 30, 2024: \$49,928.67

All other terms and conditions of BOS Agreement No. 22-211 shall remain in full force and effect.
