# **Exhibit A**

# **Statement of Work**

#### 1.0 Introduction

Upon execution of the Order Schedule, and in consideration for the payment of the applicable fees, Planet will perform services (the "Services") for the Government of Mendocino County (the "Licensee") as described in this Exhibit A. All capitalized terms used and not expressly defined in this Statement of Work will have the meanings given to them in the Order Schedule or Agreement.

## 2.0 Scope of Services

Planet shall provide Services to the Licensee by fulfilling Service Orders, delivering a total number of Services hours as defined by the Order Schedule. All Services will be initiated with a Service Order with clearly identified requirements agreed upon by both Licensee and Planet.

Licensee may select Services from the following list of available Services.:

## A. Architecture Workshops

If selected, Planet will:

- provide Architecture Workshops. Architecture Workshops may:
  - Ensure the alignment of Licensee use-cases with the technical capabilities provided by the Planet Platform
  - Design solution architectures, the essential components and how the Planet Platform will integrate. Examples include:
    - Physical, Network and Software Architectures
    - Existing geospatial software
    - User Interfaces
    - API Interfaces
    - Operations and Maintenance
    - Scalability, capability and performance
    - Creation of architecture diagrams of future-state of the enterprise, after integration with Planet, complete with API interfaces and HTTP requests

# **B. Training and Enablement**

If selected, Planet will:

- provide training and enablement on all aspects of the Planet Platform.
   Topics may include:
  - Best practices for utilizing Planet Platform
  - Remote sensing basics
  - Using Planet imagery in your geospatial software (ArcGIS, QGIS or



- GEE)
- Python and Planet APIs
- Ordering imagery with Planet's Data and Orders APIs
- Constructing tool chains with Planet's Orders API: clipping, band math, registration, file formats conversion and more
- Ordering imagery with Planet's Subscriptions API
- Planet's Tasking API for ordering high resolution SkySat tasks
- Planet's Mosaics API and accessing and utilizing Planet Basemaps
- Finding the best pixels over areas of interest with Planet's Usable Data Mask 2 product

## C. Integration Support

If selected, Planet will:

- provide integration support:
  - o utilize Planet experts to augment Licensee development teams
  - avoid technical missteps and ensure integrations are build for scale and efficiently utilize Planet's APIs
  - Planet developers can deliver functional software that can be dropped into the Licensee enterprise. Examples may include:
    - Integration of Planet capabilities with new or existing analytic workflows
    - Integration of Planet capabilities with new or existing geospatial infrastructure
    - Integration of Planet imagery with Licensee's compute or analytics layer
    - Integration of Planet Platform with cloud or on-prem storage
    - Project planning
    - Virtual machine and server configuration
    - Database setup and configuration
    - Imagery storage integration
    - Imagery rendering
    - Server performance monitoring and integration
    - Server security and management
    - SkySat tasking monitoring and imagery ingest
    - Systems integration to include error and downtime alerting
    - Ongoing maintenance and support

# 3.0 Assumptions:

Planet has developed this proposal making the following assumptions:

 All Services will be initiated with a Service Order, in a form substantially similar to <u>Attachment 1</u> attached hereto, which Services Order will



- clearly identify the selections made by Licensee, as mutually agreed to by the parties;
- perform all tasks specifically and reasonably assigned to it by Planet, including without limitation following the instructions of Planet;
- providing all information and deliverables as reasonably requested by Planet to facilitate Planet's performance hereunder;
- be and remain current in all of Licensee's financial obligations to Planet;
- if Licensee fails to provide assistance or cooperation reasonably necessary for Planet to carry out the Services described in this Services Order or fails to timely complete or comply with any Licensee Obligation hereunder, Planet's obligations may be suspended for a period of time corresponding to any delay. For the avoidance of doubt, any other obligations of Licensee shall not be affected by any delay or non-performance and any payments shall be made when originally due.

## Planet Responsibilities:

 Timely communication with Licensee on scoped project tasks and questions.

## Licensee Responsibilities:

- Timely communication with Planet on project requirements, feedback and questions.
- Clearly identify project requirements as Service Orders in writing in as much detail as possible.
- Attend regularly scheduled project meetings.

## 4.0 Schedule:

Planet will advise Licensee regarding the estimated number of hours expected to complete the requested services, and the schedule for delivery of each Service Order will be agreed upon by both Licensee and Planet and referenced within each Service Order.

# 5.0 Pricing & Payment:

The pricing is as set forth in the Order Schedule and shall be billed and paid for as set forth therein. Services hours must be used by the end of the contract term or those Services hours shall automatically expire and be deemed delivered.
