Transition from Emergency Response to Recovery


- Federal, state & local taskforces formed to support activities
- Established local recovery organizational structure
- Working with State and Federal partners on recovery support

Challenges

- Magnitude of local disaster in context of state & federal disasters
- No local disaster recovery plan in our Emergency Operations Plan
- Minimal resources available to focus on recovery

Debris Management

USACE Debris Removal Information Line: 877-875-7681



Phase 1:

- DTSC Hazardous Household Waste removal

Phase 2:

- USEPA asbestos abatement
- USACE lead agency for debris removal
- County responsibilities to process ROEs, private cleanup, release cleared site notices to property owners

Challenges:

- Properties that are difficult to access
- USACE multiple debris removal contracts with ECC, Ashbritt, CERES
- Interim state contract with ECC
- Property owner issues and resolutions
- Road damage as a result of debris removal

Housing: Immediate, Short Term, and Priority Setting

Successes of Housing Task Force Work

- FEMA lead agency; first California Housing Task Force
- Transitional housing assistance
- Direct housing eligibility and placement
- Unique housing solutions - RVs, USACE Kyen campground
- County administrative permits allow RVs on private land

Challenges

- FEMA solutions are immediate and short term
- Redwood Valley Water District infrastructure
- Planning and building support for fire survivors
- *2% vacancy rate prior to disaster - lack of available housing for renters and lack of development*

Watershed Management

- Watershed protection and erosion mitigation
- WERT Report
 - Watershed Emergency Response Team identified potential risks and warning system in case of hard rainfall
- Debris Flow Plan: additional early warning for high risk areas

- Topical meetings to inform and listen to community

Mendocino - Rebuilding Our Community (M-ROC)

- Multi-agency local partnership to identify, prioritize and coordinate disaster-related needs for individuals and families affected by the Redwood Complex Fire.

- Case Management for survivor recovery planning and resource navigation

and withstand and recover rapidly from disruptions.*



Moving Toward a Long Term Community Recovery Plan

Mendocino County Resiliency Planning

- Involves all stakeholders for whole community input
- Identifies and prioritizes projects to enhance community resilience in the face of disaster
- Leverages federal, state, local, public and private funding for recovery activities
- Produces an achievable plan adopted by local officials



Recovery Core Capabilities for Long Term Community Plans



- Community Planning and Capacity Building
- Education, Health and Social Services
- Economics and Industry
- Housing
- Infrastructure Systems
- Natural and Cultural Resources Protection
- Emergency Services and Preparedness

Desired Outcomes for a Long Term Community Recovery Plan



- Identify and prioritize recovery projects in Recovery Core Capabilities
- Identify needs and issues; develop goals, strategies and measurable objectives to Build Back Better
- Secure funding for recovery projects and implement outcome measurements
- Build and maintain partnerships; empower local action; and, leverage and strengthen local networks
- Incorporate lessons learned into enhanced emergency preparedness and emergency services systems

- Current Board goals and strategies align with Recovery Core Capabilities: housing, economic development, roads/infrastructure, emergency services, fiscal sustainability
