RE: ADOPTION OF RESOLUTION AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 250002 TO PERFORM THE 2025 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON VARIOUS COUNTY MAINTANINED ROADS AT AN ESTIMATED COST OF \$6,500,000 (HOPLAND AREA)

Honorable Board Members:

The Department of Transportation (DOT) Contract Number (No.) 250002 will provide for road pavement preservation strategy of double chip seal treatment the entire length of the roadway, as well as potentially "3R" (resurfacing, restoration, and rehabilitation) work with asphalt overlays and/or full depth reclamation (FDR) on portions of the road.

The base bid (estimated \$6,500,000) of this project is to be funded through Senate Bill 1 (SB 1): The Road Repair and Accountability Act of 2017, and Road Maintenance and Rehabilitation Account (RMRA) funds, are allocated in State Fiscal Year (FY) 2025/26. The Department will not exceed funding available. This 2025 Corrective Maintenance Project constitutes Year 7 (FY 25/26) of the 20-year Annual Project Expenditure Plan as outlined in my January 8, 2019, Director's Report, which provides for corrective/preventative maintenance on the County Roads listed above.

DOT intends to advertise for bids and have the project completed this calendar year. DOT will prepare construction plans, specifications, estimates, and contract documents; advertise and award the County contract; and coordinate the project with the other governmental agencies.

I recommend and request that the Board authorize and direct the Director of Transportation to advertise for construction bids and to award DOT Contract No. 250002 up to \$6.5M, to perform the 2025 Corrective/Preventative Maintenance Project on Various County Maintained Roads. Total distance to be treated is estimated to be 14.11 miles of roadway.

The Director is also making an Assembly Bill 720 declaration, that DOT crews will do approximately \$750,000 in preparation (dig outs) and pavement marking for this corrective maintenance project (DOT Contract No. 250002), as well as additional crew efforts this year on corrective maintenance.

Department of Transportation staff have prepared a draft Resolution which provides said authorization for the Board's consideration and adoption.
