

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 16-053**

This Third Amendment to BOS Agreement No. 16-053 is entered into this 19th day of May, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and GOVERNMENTJOBS.COM INC NEOGOV, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-053 was entered into on July 12, 2016; and

WHEREAS, BOS Agreement No. 16-053 was amended for the first time on May 22, 2018 with BOS Agreement No. 16-053 A-1; and

WHEREAS, BOS Agreement No. 16-053 was amended for the second time on June 14, 2019 with Agreement No. HR 16-053 A-2; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and GOVERNMENTJOBS.COM INC NEOGOV, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053 A1 and Agreement No. HR- 16-053 A2, from June 30, 2020 to June 30, 2021; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to add Twenty Five Thousand Three Hundred Fifty One Dollars (\$25,351) to BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053 A1 and Agreement No. HR- 16-053 A2, for services in the fiscal year 2020-2021, for a revised total Agreement amount of One Hundred Fifty Nine Thousand, Six Hundred Thirty Five Dollars and Twenty Nine Cents (\$159,635.29).

NOW, THEREFORE, we agree as follows:

1. To extend the termination date set out in the original BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053 A1 and Agreement No. HR- 16-053 A2, from June 30, 2020 to June 30, 2021.

2. To add the amount of \$25,351 to BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053 A1 and Agreement No. HR- 16-053 A2, for services in the fiscal year 2020-2021, for a revised total Agreement amount of \$159,635.29.

All other terms and conditions of BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053 A1 and Standard Services Agreement No. HR- 16-053 A2 shall remain in full force and effect.


