RE: ADOPTION OF RESOLUTION APPROVING DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 230018 IN THE AMOUNT OF \$1,700.00, AND ACCEPTING THE GRANT DEED CONVEYING REAL PROPERTY FROM MICHELLE M. CORLETTE AND JAMES A. LUTTICKEN, FOR THE ACQUISITION OF RIGHTS OF WAY NEEDED FOR CONSTRUCTION OF THE ROBINSON CREEK BRIDGE ON LAMBERT LANE, COUNTY ROAD 123A, MILEPOST 0.10 (BOONVILLE AREA)

Honorable Board Members:

The Department of Transportation (DOT) is finalizing plans and specifications for the removal and replacement of the existing bridge over Robinson Creek, located on Lambert Lane, County Road 123A, milepost 0.10, in the Census Designated Place (CDP) of Boonville. All project-related costs are 100% reimbursable by the Federal Highway Administration (FHWA) Highway Bridge Program (HBP) and Toll Credits.

For this project, the County must acquire additional right of way from Michelle M. Corlette and James A. Lutticken. DOT has obtained an Acquisition of Right of Way Agreement and Grant Deed executed by the property owner for the right of way required. We now request the Board approve said Acquisition of Right of Way Agreement, DOT Agreement Number (No.) 230018, and accept the Grant Deed for the conveyance of real property to the County.

It is also recommended that the Board authorize and direct the Chair of the Board to execute the Statutory Certificate of Acceptance and direct the Clerk of the Board to submit the Grant Deed to the County Department of Transportation office for further processing and recording.


