

## RESOLUTION NO. 24-052

### **RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 240002 TO PERFORM THE 2024 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON MOUNTAIN VIEW ROAD, COUNTY ROAD 510, MILEPOST 0.00 TO MILEPOST 24.58 AT AN ESTIMATED COST OF \$7,400,000 (MANCHESTER/BOONVILLE AREA)**

WHEREAS, the Mendocino County DOT is desirous of providing road maintenance by applying a Chip Seal on the following County Road:

Mountain View Road, County Road (CR) 510, Milepost (M.P.) 0.00 to M.P. 24.58; and

WHEREAS, an estimated \$5,400,000 cost of the 2024 Corrective/Preventative Maintenance Project on Mountain View Road CR 510, M.P. 0.00 to M.P. 24.58 is anticipated to be paid 100% by available Road Maintenance and Rehabilitation Account (RMRA) funds to provide a double chip seal treatment on the entire length of the roadway; and

WHEREAS, funding to accommodate construction costs is available in Budget Unit 3041 for Fiscal Year (FY) 2023/24 and FY 2024/25; and

WHEREAS, this project will be completed to provide the maintenance required to improve and extend the usefulness of our roads; and

WHEREAS, an additional \$2,000,000 may be available in Fiscal Year (FY) 2024/25 through the State Transportation Improvement Program (STIP) for additional "3R" (resurfacing, restoration, and rehabilitation) work on Mountain View Road with asphalt overlays on sharp turns and steep grades and/or full depth reclamation (FDR) on portions of the road, pending bid additive amounts and available funding; and

WHEREAS, construction costs, including the bid additives for the 3R work that would be funded with STIP moneys, are estimated to be some \$7,400,000, and will be performed depending on the availability of funds; and

WHEREAS, the Director of Transportation believes it is prudent to authorize the Director to award DOT Contract Number (No.) 240002 up to \$7,400,000, depending on available funding; and

WHEREAS, the Director of Transportation recommends proceeding with advertisement for bids.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes the Director of Transportation to sign the Notice to Bidders inviting bids for DOT Contract No. 240002 for the 2024 Corrective/Preventative Maintenance Project on Mountain View Road, CR 510, M.P. 0.00 to M.P. 24.58, including as additives the possible 3R work;

2. Authorizes and directs the Director of Transportation to award DOT Contract No. 240002 up to \$7,400,000 depending on available funds, upon confirmation of an appropriate low responsive bidder and acceptable contract documents by County Counsel and Risk Management, and report the results to the Board through the applicable Chief Executive Officer's Report.
