RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS DELEGATING CONSTRUCTION CONTRACT CHANGE ORDER AUTHORITY TO THE PURCHASING AGENT OR DIRECTOR OF TRANSPORTATION, AS SPECIFIED, OR THEIR DESIGNEES, PURSUANT TO PUBLIC CONTRACT CODE SECTION 20142

WHEREAS, Public Contract Code Section 20142 authorizes the Board of Supervisors by ordinance, resolution, or board order to authorize the county engineer, or other county officer, to order changes or additions in the work being performed under construction contracts. Changes or additions in the work shall be ordered in writing by the county engineer, or other designated officer, and the extra cost to the county for any change or addition to the work so ordered shall not exceed five thousand dollars (\$5,000) when the total amount of the original contract does not exceed fifty thousand dollars (\$50,000), nor 10 percent of the amount of any original contract that exceeds fifty thousand dollars (\$50,000), but does not exceed two hundred fifty thousand dollars (\$250,000), the extra cost for any change or addition to the work so ordered shall not exceed twenty-five thousand dollars (\$25,000), plus 5 percent of the amount of the original contract cost in exceeds of two hundred fifty thousand dollars (\$250,000). In no event shall not exceed two hundred fifty thousand dollars (\$250,000), and contract cost in exceed two hundred fifty thousand dollars (\$250,000), the extra cost for any change or addition to the work so ordered shall not exceed twenty-five thousand dollars (\$250,000). In no event shall any such change or alteration exceed two hundred ten thousand dollars (\$210,000); and

WHEREAS, construction contracts on County buildings and properties are generally administered either by the Department of Transportation or General Services, a division of the Executive Office, depending on the type of project; and

WHEREAS, contract change orders to address both routine needs and unforeseen conditions are an expected part of construction contract administration; and

WHEREAS, such contract change orders are subject to review processes within the Department of Transportation and the General Services division; and

WHEREAS, in order to promote the efficient use of staff resources and the timely completion of public projects, it is the desire of the Board to authorize the Director of Transportation or their designee to order changes or additions in the work being performed under construction contracts administered by the Department of Transportation, and for the Purchasing Agent or their designee to order changes or additions in the work being performed under construction contracts administered by the General Services division, subject to the limits provided in Public Contract Code Section 20142 as it may be amended from time to time.

WHEREAS, the Board of Supervisors previously adopted Resolution No. 07-009 authorizing the Director of Transportation to execute change orders pursuant to Public Contract Code Section 20142, which section has been amended since 2007 to increase certain monetary limits but which Resolution did not provide for amending any monetary limits when the section was so amended.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby authorize the Director of Transportation or their designee to order changes or additions in the work being performed under construction contracts administered by the Department of Transportation, and the Purchasing Agent or their designee to order changes or additions in the work being performed under construction contracts administered by the General Services division, subject to the limits provided in Public Contract Code Section 20142 as it may be amended from time to time.

BE IT FURTHER RESOLVED that Resolution No. 07-009 is hereby superseded and replaced by this Resolution.
