#### NACO APPOINTMENTS 2023

In August I was appointed to several National Association of Counties Committees. This year I will serve as a member of the Arts and Culture Commission and the Healthy Counties Advisory Board to represent Mendocino County for this national Organization. This year's presidential theme is "Foward Together" to achieve the ultimate benefit of better outcomes through improved trust and engagement.

I attended a variety of meetings this month one was regarding the transition of the Mendo Recycle website so that we can still keep the platform and the illegal dump site reporting feature but point residents to Redwood Waste Solutions for disposal of Hazardous Materials. I also met with a realtor form Willits wanting to know more about connecting with the local community for volunteer opportunities. I have also been working this month to track down grant funds that were for re-roofing projects for qualified individuals throughout the County. For over a year I have been working with the City of Ukiah, Ukiah Police Department and Mendocino County Sheriff's Office regarding illegal camping in the Orr Creek area. This month I learned of the extremely high call volume to one apartment complex in the Second District and have been meeting with the management from the property as well as residents and County staff to try and come up with a solution. 

I was very busy in the month of August. One highlight was getting a chance to catch up with Karen Ottoboni on KZYX. In case you missed it you can listen on the KZYX Jukebox for August 9th, 2023.

I also met with a representative from Planned Parenthood of Northern California to hear about the work they are doing and how the County can partner with the while not being duplicative with the work.

I met with a member of the Friends of the Ukiah Library to talk about the future plans for the library (they need a new location or major renovation) and to hear about the programs they are offering the community including participating in the Ukiah First Friday Art Walk and the very popular Children's Farmers Market that occurs over the summer.

I had a meet and greet with the new members of the Grand Jury. This was an informal opportunity to get to know the members and to bring them up to speed on the things that I am working on. The Stepping Up Committee met to discuss the Naphcare quarterly report from the jail. This group of stakeholders meets to discuss the mental health needs of community members in the jail including suicide watch, opiate withdrawal assessments, alcohol withdrawal assessments and the amount of medications delivered.

The Re-entry Stakeholders met to revive the group working on discharging inmates from the jail back in to the community. Access to resources and housing raised to the top of the list of needs.

The BOS/MCAFD Fire Steering Committee continued to discuss a potential Fire Warden position, the Measure P funds and the importance of having enough volunteers to continue the Fire District Boards moving forward.

# CHILDRENS FARMERS MARKET AT THE UKIAH LIBRARY



It's time to talk trash. Starting this spring I planned one volunteer clean up day a month in County parks. In the month of August I worked with the Army Corp of Engineers to plan a one hour clean up on the north end of Lake Mendocino. The lake is full which has been great and its being used by boaters, people fishing and lots of picnics. With more use comes more trash because, "Litter happens". I'd like to thank the campsite hosts, the Scott Family, Calfire Chief Luke Kendall and his engine crew that came out along with my youngest daughter Andie and my oldest sister Maggie for coming to spend an hour of their Saturday to leave the planet a little bit better of a place. Always remember that you don't need a specific clean up to do your part and clean up around your neighborhood or our parks.







If you happened to be traveling along North State Street in Ukiah in the month of August you might have noticed a pile of trash and homeless encampment growing in the parking lot of the former Carl's Jr. As I worked with the Sheriff's Office and Code Enforcement to try and find a solution for the property that has recently changed hands I stopped by and asked the individual there to help load my truck with trash. The person that was staying there did move on and the fencing was moved to prevent re-population of the site. This location is an example of someone that is well known to law enforcement and the folks doing homeless services work, because of their criminal charges they are part of this population that remains highly visible to the community and has not been able to benefit from the resources that are being provided for housing.





Adventist Health held an event called "A day of rememberance and Hope" in honor of International Opioid Awarness Day. There were powerful stories from former addicts and family of those that have lost their lives to opioids.


We had a Mendocino Local Agency Formation Commission meeting where we appointed Marsha Burch as legal counsel and appointed a secondary Counsel in case necessary.

I went to the Ukiah Rotary Sunrise club to do a presentation about the reorganization of Mendocino Solid Waste Management Authority and the opportunities to add more illegal dump clean ups. I also had a chance to highlight the Overdose Hotline cards for people to report overdoses so we can encourage more people to get in to treatment.

I attended the CPUC Commission meeting in Lake County, listened in on the Rural County Representatives of California Legislative Call In session.

Periodically the Retirement System holds webinars to show employees how to plan for retirement. I took the opportunity to listen in during one of the sessions in August.

At the Economic Development & Financing Corporation we had an update about the California Investment & Innovation Project, a Draft Budget Presentation, and an update of the CDFI Recertification process.



The Inland Water & Power Commission is deep in the process of working with PG&E about the future of the Eel River Water diversion.

I am not a Board representative for Mendocino Council of Governments but watch the meetings. In August they had a presentation about the Mendocino Transit Authority and their plans to improve public transportation in the County. I wear a variety of hats in the community and we have started planning for the Hometown Holidays events in Ukiah which will include the Ukiah Parade of Lights the first Saturday of December.

I had my first meeting as a member of the Budget Ad-hoc as Vice-Chair planning in to the next fiscal year. My goal is to improve the community understanding of the budget to reduce confusion around the process and who knows what when regarding the County Budget.

The Russian River Watershed Association had our regular meeting and we discussed the current work program as well as next years Student Video initative.

The General Government Committee received a report from the Cannabis Department.

We met to plan the Annual Russian River Clean Up which will be held September 23, 2023 in conjunction with Creeks Week.

The Board had a conversation around reducing Board and Commissions to free up budget dollars and reduce constraints for quorum for Brown Act restricted Boards that have a hard time drawing members in rural areas. We also gave direction for Broadband priorities, provided funding for the Round Valley Indian Health Center to do CalFresh outreach and provided funding to the Ford Street Project for sober living beds for the Public Defenders Office. The Mendocino County Resource Conservation District was awarded a contract to provide services for General Site Clean-up and Blight removal in Round Valley.





The Great Redwood Trail Update for August

Redwood Trail Agency meeting where we
interviewed candidates for the General Manager
position (ultimately it was reopened and the new
deadline is Sept 29th). I met with City of Ukiah staff
and Louisa Morris from the Coastal Commission

various individuals who are interested in learning
