

I.

I had Submitted for the Governors Appointment in 2016-2017, And was going to run as a "write in" during the last election for the Board of Supervisors. I got all of the Signatures however, did not register to vote sooner.

1) My Horses at Cole Creek Equestrian continue to be in serious danger while out of my hands and in this area.

I'm asking for their Immediate Return to me so my Shipper can come get them safely out of here with the following Demands/Orders:

- 1) No Constriction
- 2) No Sale or Transference
- 3) No Unjust enrichment of Others
- 4) That I am able to, allowed to go help my Horses and bring my own Veterinarians
- 5) That they are maintained without Injury until my Shipper can come get them
- 6) That Roni McFadden and Darin Mille Witt, and anyone associated with them have any, that "they" do not have any access to my Horses.

I've filed an Appeal, and I have a UCC1 statement filed to protect my Horses, from Sale, transference or exploitation.

And am ready lawsuits against Civil and Court Officials who are involved in the repeated thefts of my horses and who have harmed and killed several Horses of mine, almost all foals except for my Arab Stallion Raffi who was stolen 3xs and Starved to death at Cole Creek Equestrian.

- ② I am requesting a Grand Jury Investigation into the Starvation committed by Cole Creek Equestrian against Mendocino County and me and my horses as horses of mine were starved there in

- 1) April/May 2016.
- 2) My Arab Stallion Raffi was starved to death there in 11/12/17.
- 3) 1 foal died there 1/15/18 due to Ignorance and Neglect.
- 4) 4-5 foals are missing from my Mare Herd-
- 5) When Investigator Justin Cozad, Atty Heidi Larson and I went to Cole Creek Equestrian on 1/15/19 we found-

a) My Mare Ancestressa deny as she needed to be fed separately from my Mare Herd-

- (i) 3-4 Stakes Alfalfa/dg
- (ii) "Free Choice" grass hay
- (iii) LMF Senior + drug Cob mixed together with hot or cool water depends upon the weather to soften grains twice a day.
- (iv) And need to see a Veterinarian to float her teeth, as horses get points on their back molars and cannot "masticate" chew, their feed.

b) All of my Bachelor Herd have been there this entire time without any access to shelter from the driving wind and rain. (5 male horses)

- c) My Stallion Tazi needs for me to treat him for his dermatitis daily - I have the Medicine -
- d) My Mare Anastasia needs the Medicine I have to dissolve the 'Sarcocoll'
- e) My Silly needs my hoof Preparation to prevent her from going lame
- f) My 2 Yearlings have ~~be~~ not been turned out to run on Pasture since 1/3/18 when they were seized and taken to Cole Creek Equestrian. Young Horses do not develop properly unless they can get out and Run -
- g) None of my 3 Foals are halter-schooled and are now have no daily turn-out to get out and Run. Young horses do not develop properly unless they can Run, trot, canter and Move -
- h) None of my Horses are groomed
- i) None of my horses have had their feet trimmed and filed -
etc, etc.

The Van Ecks do not know what they are doing, but my Horses and I should not have to suffer because "they" do not know what they are doing. There are other cases of horse starvation and mismanagement there. Cole Creek Equestrian is a Scam.

③ I'm also going to Request a Grand Jury Investigation into the Deaths of:

i) Dawn Centay, a good livestock Person,

a) Lidia Ditmeier

2 Friends of Mine whose deaths are directly attributed to and caused by Roni McFadden & Dr. Mike Witt and their "group" and Animal Control working "in Collusion" with Roni McFadden and her group, harassing and terrorizing horse Owners and Animal Owners and the Illegal or Unlawful seizures of these 2 women's animals and horses

④ And a Grand Jury Investigation into the targeting of me and my Horses by Roni McFadden and her "group" who includes Dr. Mike Witt and Andrew Hickey, in the repeated seizures of my Horses, where from April 2016 -> to January of 2018 there were 5 illegal or unlawful seizures, where there was never a "30-day Notice of Eviction" but rather illegal evictions, where in a 21 month period from April 2016 -> January 2018 there were 9 incidences, that's every 2-3 months, while we, me and my horses were "Gang-Stalked" by Roni McFadden and her group in collusion with Animal Control - Interfere with my care for my Horses, our feed supply, our access to Veterinary care, and access to pastures and Horse Transporters, etc.

- 1) I'm requesting that there is a G.N.H. Index Survey for Mendocino County - Gross National Happiness, Index Survey district by district.

As when I ask people what they would do to change Mendocino County, everyone has a list.

- 2) There is a "Mersa" epidemic amongst the Homeless Population in Mendocino County - and I'm requesting "Public Showers" be built, based upon the same "Public Showers" program in Germany. We can obtain a copy of the "Public Showers" from the German Government, and use this as a "Template".
