AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. 24-009

This Second Amendment to Agreement No. <u>24-009</u> is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and <u>Liebert, Cassidy, Whitmore</u>, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. 24-009 was entered into on January 23, 2024; and

WHEREAS, Agreement No. 24-009-A1 was entered into on October 8, 2024; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable from \$200,000 to \$400,000; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the period of services from June 30, 2025 to June 30, 2027.

NOW, THEREFORE, we agree as follows:

- 1. The total contracted amount set out in Agreement No. <u>24-009</u> is hereby increased from <u>\$200,000</u> to <u>\$400,000</u>.
- 2. The termination date set out in Agreement 24-009 is hereby extended from <u>June 30, 2025</u> to <u>June 30, 2027</u>.

All other terms and conditions of Agreement No. <u>24-009</u> shall remain in full force and effect.
