

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 19-240-A1**

This Amendment to Board of Supervisors Agreement No. 19-240-A1 is entered into this _____ day of _____, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and THOMAS LAW GROUP, hereinafter referred to as "CONTRACTOR".

WHEREAS, Purchasing Agent Agreement No. 20-32 was entered into on July 26, 2019; and

WHEREAS, Board of Supervisors Agreement No. 19-240 amending Purchasing Agent Agreement No. 20-32 was entered into on October 1, 2019; and

WHEREAS, Board of Supervisors Amendment Agreement No. 19-240-A1 amending Board of Supervisors Agreement No. 19-240 was entered into on January 21, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and THOMAS LAW GROUP, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount payable to CONTRACTOR in the Agreement No. 19-240-A1, from \$280,000 to \$365,000; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend termination date set out in the original Agreement No. PA-20-32, from June 30, 2020 to June 30, 2021.

NOW, THEREFORE, we agree as follows:

1. The total amount payable to CONTRACTOR shall be increased from \$280,000 to \$365,000.
2. The termination date set out in the original Agreement No. PA-20-32 is extended from June 30, 2020 to June 30, 2021.

All other terms and conditions of Purchasing Agent Agreement No. 20-32 shall remain in full force and effect.
