

RESOLUTION NO. 19-034

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING NOTICE OF COMPLETION AND RELEASE OF CONTRACT SURETY, DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 180058, REMOVAL OF FIRE-DAMAGED TREES THAT PRESENT A SAFETY HAZARD AS A RESULT OF THE 2017 REDWOOD FIRE (REDWOOD VALLEY & POTTER VALLEY AREA)

WHEREAS, by Resolution Number (No.) 18-097 adopted July 10, 2018, the Mendocino County Board of Supervisors authorized Department of Transportation (DOT) to advertise and award DOT Contract No. 180058; and

WHEREAS, on August 10, 2018, DOT awarded DOT Contract No. 180058 to Family Tree Service of Laytonville, California, for Removal of Fire-Damaged Trees that Present a Safety Hazard as a Result of the 2017 Redwood Fire; and

WHEREAS, final inspection and submission of contract records for the construction activity on the project was made pursuant to the Recommendation for Acceptance and filing of Notice of Completion accompanying this resolution; and

WHEREAS, Section 9204 of the California Civil Code provides that a public entity may record a notice of completion on or within 15 days after the date of completion of a work of improvement and Section 9200 provides that completion of a work of improvement occurs at the earlier of the acceptance of the work of improvement by the public entity or the cessation of labor on the work of improvement for a continuous period of 60 days; and

WHEREAS, Section 9356 of the California Civil Code provides that a stop payment notice is not effective unless given before the expiration of 30 days after the recordation of a Notice of Completion; and

WHEREAS, Section 9558 of the California Civil Code provides that a claimant may commence an action to enforce the liability on a payment bond no later than six months after the period in which a stop payment notice may be given under Section 9356 of the Civil Code; and

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors:

1. Accepts the completed work, approves the form of Notice of Completion, and authorizes the Director of Transportation to execute the Notice of Completion for DOT Contract No. 180058 and file it with the County Recorder; and
2. Authorizes and directs the Director of Transportation to release, in accordance with the following schedule, the contract bonds filed by the contractor, Family Tree Service, P.O. Box 1325, Laytonville, CA, 95454, pursuant to the provisions of DOT Contract No. 180058 executed August 10, 2018; and
3. Authorizes and directs the Director of Transportation to release, thirty days from the date of recordation of Notice of Completion, upon confirmation with the Clerk of the Board and the Auditor that no claims or lawsuits have been filed against same, the Performance Bond (No. 706539P) in the amount of \$364,490.79 issued by the Indemnity Company of California, 17771 Cowan, Suite 100, Irvine, CA, 92614; and

4. Authorizes and directs the Director of Transportation to release, thirty days plus six months from the date of the recordation of Notice of Completion, providing no claims or lawsuits have been filed against same, the Labor and Materials Bond (No. 706539P) in the amount of \$364,490.79 issued by the Indemnity Company of California, 17771 Cowan, Suite 100, Irvine, CA, 92614.
