

**AMENDMENT TO STANDARD SERVICES
AGREEMENT NO. PA 20-136**

This Amendment to Standard Services Agreement No. PA 20-136 is entered into this 9th day of March, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and LIEBERT CASSIDY WHITMORE, hereinafter referred to as "CONTRACTOR".

WHEREAS, Standard Services Agreement No. PA 20-136 was entered into on June 17, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and LIEBERT CASSIDY WHITMORE, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the COUNTY to increase the amount of Standard Services Agreement No. PA 20-136 by Thirty Thousand Dollars (\$30,000) for investigation services performed during the term of this Agreement, for a total Agreement amount of Seventy Seven Thousand, Five Hundred Dollars (\$77,500).

NOW, THEREFORE, we agree as follows:

1. To increase the amount of Standard Services Agreement No. PA 20-136 by \$30,000 for investigation services performed during the term of this Agreement, for a total Agreement amount of \$77,500.

All other terms and conditions of Standard Services Agreement No. PA 20-136 shall remain in full force and effect.
