

RESOLUTION NO. 23-009

A RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF MENDOCINO, CALIFORNIA AUTHORIZING THE-EXTENSION OF THE ABANDONED VEHICLE ABATEMENT PROGRAM

WHEREAS, by Resolution No. 13-013, established a service authority for abandoned vehicle abatement in Mendocino County and authorized the County Chief Executive Officer to execute a Joint Powers Agreement ("JPA") for the Mendocino County Abandoned Vehicle Abatement Service Authority ("Authority"); and

WHEREAS, pursuant to California Vehicle Code section 9250.7 and the JPA, an annual service fee of one dollar (\$1) on vehicles registered to an owner with an address in the County is imposed, to be used by the Authority for abandoned vehicle abatement; and

WHEREAS, the Abandoned Vehicle Abatement program has contributed \$1,111,068.08 over the past ten (10) years and allowed for the abatement of one thousand two hundred thirty five (1,235) abandoned vehicles in Mendocino County; and

WHEREAS, pursuant to subdivision (g) of California Vehicle Code section 9250.7, the fee imposed by the Authority remains in effect only for a period of ten (10) years from the date that actual collection of the fee commenced; provided that the fee may be extended in increments of up to 10 years each, if the Board of Supervisors of the county, by a two-thirds vote, and a majority of the cities having a majority of the incorporated population within the County adopts resolutions providing for the extension of the fee; and

WHEREAS, it is desirable to the County of Mendocino to have the program continue;

NOW, THEREFORE, BE IT RESOLVED, the Mendocino County Board of Supervisors supports the extension of the Abandoned Vehicle Abatement program until February 2033.

BE IT FURTHER RESOLVED, that the Board of Supervisors directs the Department of Planning and Building Services transmit this Resolution and to continue the Abandoned Vehicle Abatement Program.


The foregoing Resolution introduced by Supervisor Williams, seconded by Supervisor Mulheren, and carried this 10th day of January, 2023, by the following vote:




