

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 16-053**

This Fifth Amendment to BOS Agreement No. 16-053 is entered into this 12th day of July, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and GOVERNMENTJOBS.COM INC. NEOGOV, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-053 was entered into on July 12, 2016; and

WHEREAS, BOS Agreement No. 16-053 was amended for the first time on May 22, 2018 with BOS Agreement No. 16-053-A1; and

WHEREAS, BOS Agreement No. 16-053 was amended for the second time on June 19, 2019 with Standard Services Agreement No. HR 16-053-A2; and

WHEREAS, BOS Agreement No. 16-053 was amended for the third time on May 19, 2020 with BOS Agreement No. 16-053-A2; and

WHEREAS, BOS Agreement No. 16-053 was amended for the fourth time on April 2, 2021 with Standard Services Agreement No. HR 21-04 and;

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the Fourth Amendment Agreement No. HR 21-04, from June 30, 2022 to June 30, 2023; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to add the amount of Twenty-Eight Thousand Six Hundred Forty-Nine Dollars and Thirty Four Cents (\$28,649.34) for Fiscal Year 2022/2023, for a revised total Agreement amount of Two Hundred Sixty Two Thousand Two Hundred Thirty-Six Dollars (\$262,236).

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Fourth Amendment Agreement No. HR 21-04 is hereby extended from June 30, 2022 to June 30, 2023.

2. The amount set out in the Fourth Amendment Agreement No. HR 21-04 is hereby increased by \$28,649.34 for Fiscal Year 2022/2023 for employment services and software licensing for a revised total Agreement amount of \$262,236.

All other terms and conditions of BOS Agreement No. 16-053 as amended with BOS Agreement No. 16-053-A1; Standard Services Agreement No. HR 16-053-A2; BOS Agreement No. 16-053-A2; and Standard Services Agreement No. HR 21-04, shall remain in full force and effect.
