AMENDMENT NUMBER 2 TO DEPARTMENT OF TRANSPORTATION AGREEMENT NO. 190028 / BOARD OF SUPERVISORS AGREEMENT NO. 20-014, STANDARD SERVICES AGREEMENT WITH WYLATTI RESOURCE MANAGEMENT INC., FOR LEACHATE MONITORING AND HAULING SERVICES FOR LAYTONVILLE AND CASPAR LANDFILLS

This Amendment Number (No.) 2 is entered into this <u>20TH</u> day of <u>APRIL</u>, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Wylatti Resource Management Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, Board of Supervisors (BOS) Agreement No. 20-014/Department of Transportation (DOT) Agreement No. 190028 was entered into on February 26, 2020, for leachate monitoring and hauling services for Laytonville and Caspar Landfills; and

WHEREAS, Amendment No. 1 to BOS Agreement No. 20-014/DOT Agreement No. 190028 was entered into on October 1, 2020; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, more leachate has been generated this year than anticipated; and

WHEREAS, additional funds will be required to perform the necessary leachate hauling services through the end of this year's leachate generation period; and

WHEREAS, it is estimated that an additional \$50,000 will be sufficient funds to perform the services for the remaining term of the agreement, resulting in a revised not-to-exceed amount for BOS Agreement No. 20-014/DOT Agreement No. 190028 of \$127,000.

NOW, THEREFORE, we agree as follows:

1. The total not to exceed compensation payable to the contractor is increased by \$50,000 from \$77,000 to a not-to-exceed amount of \$127,000; and

All other terms and conditions of BOS Agreement No. 20-014/DOT Agreement No. 190028 shall remain in full force and effect.
