## SECOND AMENDMENT TO COUNTY OF MENDOCINO AGREEMENT NO. PA-20-133

WHEREAS, Agreement No. PA-20-133 was entered into on June 10, 2020; and

WHEREAS, first Amendment, BOS Agreement No. 23-093 was entered into on June 6, 2023; and

WHEREAS, upon execution of this document by CONTRACTOR and COUNTY, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in first Amendment, BOS Agreement No. 23-093, from June 30, 2024 to June 30, 2025; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the maximum amount set out in first Amendment BOS Agreement No. 23-093, from \$66,666.66 to \$83,333.32.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in first Amendment BOS Agreement No. 23-093 is hereby extended from June 30, 2024 to June 30, 2025.
- 2. The maximum amount set out in first Amendment BOS Agreement No. 23-093 is hereby increased from \$66,666.66 to \$83,333.32.
- 3. Exhibit B, Payment Terms, set out in first Amendment BOS Agreement No. 23-093 has been altered and a new Exhibit B is attached herein with changes denoted in bold font.

All other terms and conditions of Agreement No. PA-20-133, and first Amendment BOS Agreement No. 23-093 shall remain in full force and effect.
