

**AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. PH-21-012**

This Amendment to Agreement No. PH-21-012 is entered into this 7th day of January, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Schat's Bakery**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PH-21-012 was entered into on September 27, 2021; and

WHEREAS, upon execution of this document by the County of Mendocino and the CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in the original Agreement No. PH-21-012 from \$25,000 to \$50,000; and

WHEREAS, CONTRACTOR will continue to provide food preparation and delivery services during the COVID-19 pandemic.

NOW, THEREFORE, we agree as follows:

1. The amount set out in the original Agreement No. PH-21-012 will be increased from \$25,000 to \$50,000.

All other terms and conditions of Agreement No. PH-21-012 shall remain in full force and effect.
