

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 17-158**

This Third Amendment to BOS Agreement No. 17-158 is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and VISION SERVICE PLAN, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 17-158 was entered into on December 19, 2017; and

WHEREAS, Standard Services Agreement No. HI 19-04 was entered into on October 9, 2018; and

WHEREAS, Standard Services Agreement No. HI 20-001 was entered into on February 12, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and VISION SERVICE PLAN, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 17-158 as amended with Standard Services Agreement No. HI 19-04 and Standard Services Agreement No. HI 20-001, from December 31, 2020 to December 31, 2023; and

WHEREAS, the original BOS Agreement No. 17-158 as amended with Standard Services Agreement No. HI 19-04 and Standard Services Agreement No. HI 20-001 is increased in the amount of One Hundred Sixty Seven Thousand, Nine Hundred Sixty Four Dollars (\$167,964) for employee vision insurance benefits to be provided in calendar years 2021 through 2023, for a total Agreement amount of \$435,134.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 17-158 as amended with Standard Services Agreement No. HI 19-04 and Standard Services Agreement No. HI 20-001 will be extended from December 31, 2020 to December 31, 2023.
2. BOS Agreement No. 17-158 as amended with Standard Services Agreement No.

HI 19-04 and Standard Services Agreement No. HI 20-001 is increased in the amount of \$167,964 for employee vision insurance benefits to be provided in calendar years 2021 through 2023, for a total Agreement amount of \$435,134.

All other terms and conditions of BOS Agreement No. 17-158 as amended with Standard Services Agreement No. HI 19-04 and Standard Services Agreement No. HI 20-001 shall remain in full force and effect.
