SECOND AMENDMENT TO PURCHASING AGREEMENT NO. PA 21-33

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in Amendment No. BOS 21-180, from August 5, 2022 to August 5, 2023; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in Amendment No. BOS 21-180, from \$58,500 to \$87,750; and

WHEREAS, CONTRACTOR will continue to provide live closed captioning services.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in Amendment No. BOS 21-180 is hereby extended from August 5, 2022 to August 5, 2023.
- 2. The amount set out in Amendment No. BOS 21-180 is hereby increased from \$58,500 to \$87,750.

All other terms and conditions of Agreement No. PA 21-33 and Amendment No. BOS 21-180 shall remain in full force and effect.
