# **MEMORANDUM**

RE: PBS FEE UPDATE

The Department of Planning and Building Services fees have been updated regularly every two years since approximately 2013. Recent fee updates have taken cost recovery into account, however this specific update to the Building Division will now progress all division fees from a unit cost to time estimates and International Code Council (ICC) Valuation Tables, to increase the County's ability to recapture costs. It is anticipated that Planning and Building fees will be reviewed on an annual basis to address full cost recovery, as the Board has directed, and this update is the catalyst to that change. This fee update will utilize the published ICC Valuations from 2023, which reflect the 2021 International Building Codes and represent a 35% increase to occupancy groups from the previously adopted valuation. To coincide with the ICC Valuations, the Mendocino County specialized valuations have also been increased by approximately 35%, except for Solar fees, which are regulated by the State of California. Additional information is provided below for each attachment to this document.

## Building Division Attachment A- ICC Valuation Table and Mendocino County Updates:

The ICC valuation data is updated and released to the members every six months. As such, most Building Departments use this information as the source to update fees to ensure consistency through permitting and valuation of construction projects. Valuation tables are used to create the actual cost of a building permit by estimating the "job cost" for a project or the "valuation" of the construction. This value is then used in a formula to create plan review fees and basic construction costs. Other review fees associated with each permit that are time based, including inspections can be found in each relevant fee, such as Electrical, Mechanical or Plumbing. The inspection times are captured within the permit fees and are discussed in Attachment's B and C. Mendocino County has been updating the valuation tables within the building fees every two years, along with other specific fees annually as needed. The top portion of Attachment A is an export of the ICC Building Valuation Table, which notes the Group Occupancy from the 2021 International Codes. During each Building Code adoption cycle, the County routinely updates specialized valuations that may not exist in the ICC Table or have a special use in Mendocino County due to our unique community and character. The bottom portion of the attachment lists the necessary valuations to update in Mendocino County and maintain a 35% increase, except where fees are regulated by outside entities.

## **Building Division Attachment B- Master Fees and Miscellaneous Valuation Tables**

Attachment B is the Building Division Master Fee schedule and is a combination of all applicable fees and the smaller valuation tables not included in the ICC updates. This document has been changed drastically over time and this revision deletes all unit costs and provides an update to cost recovery. The initial valuation table on rows 3 through 18 has been increased by approximately 10% and brings the occupancy table into a comparable rate with Humboldt and Sonoma Counties. The following sections labeled Electrical Permit Fees, Mechanical Permit Fees and Plumbing Permit Fees have all been updated for cost recovery on the time spent for each aspect of the application, from intake, issuance to final inspections, based on the average time staff and an inspector would spend on the permit. Also duplicate fees that are no longer necessary or have not been

used in the past 5 years have been selected for deletion and are noted by strikeout text. The time spent on these permits ranges from 5 minutes to several hours, which is now figured into the fees. Elevator Permit Fees beginning on row 152 have been combined into a single fee and valuation of job cost as there is little activity related to this type of permit in Mendocino County and multiple fees and valuations are not necessary. Building Plan Review Fees on rows 164 through 180 are not recommended to increase as this is a formula calculation off of the permit fees, which are directly listed in the ICC Valuation Table. The Grading Permit Fees have been updated partially to bring them into conformance with the adopted valuation tables published by ICC, which have a higher initial fee and reduced fractional charges as the cubic yards increase. Manufactured Home permit fees have been recalculated based on staff time for application, and inspections, which increased several of the fees but did result in a reduction to the Triple Wide fee, as overall inspection times are similar. Other Permit Fees have been reevaluated utilizing cost recovery time for all staff involved in the permit, which generally, raised each fee. Several fees are not suggested to increase such as the General Plan Maintenance fee, which is still within market rate and the Education fees as adopted by AB717 is also in a similar range to other counties.

#### Building Division Attachment C- Mileage Calculation for Special Inspection/Pre-site Inspections

Attachment C is the breakdown of mileage charges for special inspections and pre-site inspections that occur outside of the regular inspection days. This additional fee will cover the cost of travel to and from various locations on the days that inspectors are typically not in the area. For example, Anderson Valley inspections are scheduled on Monday and Wednesday, and would require a special inspection for any other day of the week. As such, an additional mileage charge is added into the special inspection to cover the average distance from the inspection to the office.
