ACQUISITION OF RIGHT OF WAY AGREEMENT**

This Amendment Number (No.) 1 to Board of Supervisor (BOS) Agreement No. 23-096/Department of Transportation (DOT) Agreement No. 220027 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Diane L. Pintane, as Successor Trustee of the Robert L. Pintane and Diane L. Pintane Revocable Trust dated August 9, 2002, hereinafter referred to as "OWNER," the date this Amendment is fully executed by all parties.

WHEREAS, BOS Agreement No. 23-096/DOT Agreement No. 220027 was entered into on June 6, 2023; and

WHEREAS, upon execution of this document by COUNTY and OWNER, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, the following conditions have changed since the execution of the original Acquisition of Right of Way Agreement as follows:

1. The death of Robert L. Pintane, Trustee of the Robert L. Pintane and Diane L. Pintane Revocable Trust dated August 9, 2002; and
2. Diane L. Pintane, is now the Successor Trustee of the Robert L. Pintane and Diane L. Pintane Revocable Trust dated August 9, 2002.

NOW, THEREFORE, COUNTY and OWNER agree that all other terms and conditions of BOS Agreement No. 23-096/DOT Agreement No. 220027 shall remain in full force and effect.

THE PARTIES HERETO HAVE set forth the whole of their Agreement. The performance of this Agreement constitutes the entire consideration of said document and shall relieve COUNTY of all further claims on this account or on account of the location, grade, or construction of the proposed public improvements.
