

**AMENDMENT TO COUNTY OF MENDOCINO
PURCHASING AGENT AGREEMENT NO. 22-01, PH-21-013**

This second Amendment to Agreement No. PA 22-01, PH 21-013 is entered into this 21st day of June, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **DJ Consulting**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 22-01, PH-21-013 was entered into on October 8, 2021; and

WHEREAS, first Amendment Agreement No. PA 22-01-A1, PH-21-013-A1 was entered into on January 20, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the first Amendment Agreement No. PA 22-01-A1, PH-21-013-A1, from June 30, 2022 to June 30, 2023; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in the original Agreement No. PA 22-01, PH-21-013 from \$50,000 to \$100,000.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the first Amendment Agreement No. PA 22-01-A1, PH-21-013-A1 is hereby extended from June 30, 2022 to June 30, 2023.
2. The amount set out in the original Agreement No. PA 22-01, PH-21-013 is hereby increased from \$50,000 to \$100,000.

All other terms and conditions of Agreement No. PA 22-01, PH-21-013, and PA 22-01-A1, PH-21-013-A1 shall remain in full force and effect.
