## AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 22-281

This Amendment to BOS Agreement No. <u>22-281</u> is entered into this 17th day of October, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Paula E. Groves DBA 4Front Partners, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 22-281 was entered into on December 6, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the maximum total compensation payable to CONTRACTOR.;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, COUNTY AND CONTRACTOR agree as follows:

- Maximum Compensation. The maximum compensation payable to <u>CONTRACTOR under BOS Agreement No. 22-281</u> shall be increased by a total of One Hundred Forty-One Thousand and Seven Hundred Eighteen Dollars and Seventy-Five Cents (\$141,718.75) for a new total of, and not to exceed, Three Hundred Twenty-Six Thousand Four Hundred and Forty-Three Dollars and Fifty Cents (\$326,443.50).
- 2. Amendment to Section 19. Section 19 of BOS Agreement No. 22-281 shall be amended and replaced as follows:

TERMINATION. The COUNTY has and reserves the right to suspend, terminate or abandon the execution of any work by the CONTRACTOR without cause at any time upon giving the CONTRACTOR notice. Such notice shall be in writing and may be issued by an county officer authorized to execute or amend the contract, the County Chief Executive Officer, or any other person designated by the County Board of Supervisors. In the event that COUNTY should abandon, terminate or suspend the CONTRACTOR's work, the CONTRACTOR shall be entitled to

payment for services provided hereunder prior to the effective date of said suspension, termination or abandonment. Said payment shall be computed in accordance with Exhibit B hereto, provided that the maximum amount payable to CONTRACTOR for its Cannabis Equity Grant Administration Services shall not exceed \$326,443.50 in payment for services provided hereunder prior to the effective date of said suspension, termination or abandonment or lack of funding.

All other terms and conditions of BOS Agreement No. <u>22-281</u> shall remain in full force and effect.
