

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 21-076**

This Amendment to BOS Agreement No. 21-076 is entered into this _____ day of _____, 2022, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Davis Guest Home**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-076 was entered into on July 1, 2021; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount in BOS Agreement No. 21-076, from \$218,431 to \$242,431; and

WHEREAS, CONTRACTOR will continue to provide services as a residential care facility offering a broad range of services to residents requiring a structured environment due to mental health challenges.

NOW, THEREFORE, we agree as follows:

1. The amount set out in BOS Agreement No. 21-076 is hereby increased from \$218,431 to \$242,431.

All other terms and conditions of BOS Agreement No. 21-076 shall remain in full force and effect.
