Special Expertise, Experience, or Interest in This Area?

I have worked in Public Health for almost 12 years. Every position I have held in Public Health has provided me with unique exposure to nearly every aspect of the role Public Health plays in our community, as well as the capabilities of our Public Health organization. These positions have also enabled me to establish relationships with diverse groups of people and partners, including schools, law enforcement agencies, local government officials, parents, and community members. I started working on the Coast, leading two local coalitions that engaged in reducing alcohol and drug use by youth and tackling the opioid epidemic. The coalitions advocated for the passage of a social host ordinance by the City of Fort Bragg and supported the distribution of Narcan. The Fort Bragg Police Department was the first law enforcement organization in Mendocino County to carry Narcan, and our Safe RX Coalition distributed Narcan to the public. When COVID-19 hit, I had to leave my position and work full-time on COVID-19 case investigation, contact tracing, and outbreak management. I was an emergency worker for three long years until I sent the email that marked the end of the pandemic and the closing of the Public Health COVID-19 unit. Since then, I have managed Communication for Public Health. I now manage Public Health Accreditation and the Community Health Needs Assessments (CHNA) and the Community Health Improvement Plan (CHIP). This year's CHNA and CHIP are the first in which we are partnering with Adventist Health and engaging our Tribal partners. I hope to bring this experience to the Public Health Advisory Board and represent the people who work in Public Health.
