THIRD AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 23-042

This Third Amendment to BOS Agreement No. <u>23-042</u> is entered into this <u>25th</u> day of <u>June</u>, 2024, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>KRONICK</u>, <u>MOSKOVITZ</u>, <u>TIEDEMANN & GIRARD</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. <u>23-042</u> was entered into on <u>3/28/23</u> (the "Initial Agreement"); and

WHEREAS, Amendment to BOS Agreement No. <u>23-043-A1</u> was entered into on <u>10/31/23</u> (the "First Amendment") increasing the total amount by \$200,000 for a new total of \$400,000; and

WHEREAS, Amendment to BOS Agreement No. <u>23-043-A2</u> was entered into on <u>3/12/24</u> (the "Second Amendment") increasing the total amount by \$300,000 for a new total of \$700,000; and

WHEREAS, the Initial Agreement, First Amendment and Second Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>KRONICK</u>, <u>MOSKOVITZ</u>, <u>TIEDEMANN & GIRARD</u>, this third amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount payable from \$700,000 to \$1,400,000.

NOW, THEREFORE, we agree as follows:

1. The total amount payable set out in the Agreement will be increased from \$700,000 to \$1,400,000.

All other terms and conditions of Agreement shall remain in full force and effect.
