## AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 23-053

This Amendment to BOS Agreement No. <u>23-053</u> is entered into this 29th day of August 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>Jeff Tyrrell Communications</u>, <u>LLC</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 23-053 was entered into on April 11, 2023; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>Jeff Tyrrell Communications</u>, <u>LLC</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>23-053</u>, from <u>June 30</u>, <u>2023</u> to <u>June 30</u>, <u>2024</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount payable date set out in the original BOS Agreement No. <u>23-053</u>, from <u>fifteen thousand dollars (\$15,000.00)</u> to <u>sixty thousand dollars (\$60,000.00)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>23-053</u> will be extended from 06/30/2023 to 06/30/2024.
- 2. The total compensation set out in the original BOS Agreement No. <u>23-053</u> will be increased from <u>\$15,000.00</u> to <u>\$60,000.00</u>.

All other terms and conditions of BOS Agreement No. <u>23-053</u> shall remain in full force and effect.
