Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall include language in the 2018 Legislative Platform that a portion of the State cannabis tax should go towards education to children not to partake in recreational cannabis as well as education to parents on the impact of cannabis on the young brain.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall include the Fiscal Fire Related Legislative Requests and the Policy Fire Related Legislative Requests that were included in letter sent to Governor Brown and Director Ghilraducci on January 9, 2018, by Lake, Mendocino, Napa, and Sonoma counties in the 2018 Legislative Platform; with a clause noting that this request is supported by all four counties.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that a review of Disability Pensions shall be included in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall include consolidation of the Water Districts in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall include issues surrounding the Land to Trust Program and Comment Period in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that the Federal Energy Regulatory Commission (FERC) relicensing process currently underway with the Potter Valley project shall be included in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall include the Feasibility Study for the raising of the Coyote Valley Dam in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE for staff to include language to support coastal dependant businesses by opposing Federal leases offshore regarding offshore drilling in the 2018 Legislative Platform.

Committee Directive: GENERAL CONSENSUS OF THE COMMITTEE that staff shall send a draft of the 2018 Legislative Platform to the Committee members and will work with Clerk of the Board staff to bring the item to the full Board of Supervisors at the next available meeting in March.
