

RESOLUTION NO. 24-116

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS ESTABLISHING THE APPROPRIATIONS LIMIT FOR THE COUNTY OF MENDOCINO FOR FISCAL YEAR 2024-25

WHEREAS, Government Code section 7910 mandates that the governing body of each local jurisdiction establish the appropriations limit for each fiscal year by passage of a resolution; and

WHEREAS, Article XIII B of the California Constitution has been amended by Proposition 111 to change the price and population factors that may be used by local jurisdictions in setting appropriations limits; and

WHEREAS, the documents evidencing the calculation of the fiscal year 2024-25 Gann limit have been made available to the public fifteen days prior to the scheduled and noticed meeting of the Mendocino County Board of Supervisors. Such documents were published on the website of the Mendocino County Auditor-Controller.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors that the following is adopted as the appropriations limit for the County of Mendocino for fiscal year 2024-25 is set as follows:
