NOTICE OF PUBLIC MEETING FOR DISCUSSION OF POSSIBLE STATE CDBG APPLICATION & USE OF PROGRAM INCOME FUNDS

NOTICE IS HEREBY GIVEN that the County of Mendocino will conduct a public meeting on November 4, 2025, to discuss possible applications for funding under the State Community Development Block Grant (CDBG) Program and potential activities to be included in the applications. The meeting will be held during the regularly scheduled Board of Supervisors meeting on November 4, 2025, at 9:00 a.m. or as soon thereafter as the agenda item may be heard in Board Chambers at 501 Low Gap Road, Ukiah, California 95482.

The Board of Supervisors will consider the allocation of \$479,931 in Community Development Block Grant (CDBG) Program Income to support two projects:

- Centro Negocio West (CNW) | Spanish Language Microenterprise Technical Assistance Project | \$100,000
- County of Mendocino | Business Loan Program | \$379,931

The selected projects support low- and moderate-income (LMI) residents by offering culturally responsive technical assistance, counseling, and training to microenterprises, along with workshops and networking opportunities. In addition, these projects provide low-interest loans to businesses that create or retain jobs for low- and moderate-income residents and strengthen economic resilience. The Board will consider adopting a resolution authorizing the submission of program income applications to the California Department of Housing and Community Development (HCD) and the execution of related grant agreements.

The County of Mendocino has approximately \$479,931 in available CDBG Program Income, prior to approval of these applications, to put towards CDBG projects.

The purpose of this hearing is to review CDBG eligible activities and collect residents' views on housing and community development needs (which includes services, facilities, and/or infrastructure that will improve livability within the community).
