AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 23-025

This Amendment to BOS Agreement No. <u>23-025</u> is entered into this 26th day of September, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>4Leaf, Inc.</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 23-025 was entered into on February 28, 2023; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and 4Leaf, Inc., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>23-025</u>, from <u>December 31, 2023</u> to <u>December 31, 2024</u>; and

WHEREAS, 4Leaf, Inc. will continue to conduct a complete review of all received ministerial Cannabis Cultivation Permit applications.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>23-025</u> will be extended from December 31, 2023 to December 31, 2024.
- 2. The compensation payable to 4Leaf, Inc. will be increased by a total of One Million Two Hundred Six Thousand Dollars (\$1,206,000.00) for a new total of, and not to exceed, Two Million Eight Thousand Six Thousand Dollars (\$2,806,000.00).

All other terms and conditions of BOS Agreement No. <u>23-025</u> shall remain in full force and effect.
