Contract Comparison

- Proposal would be to lease new machines for a three-year period, at which time the machines could then be traded in for a cash rebate.
 - The cash rebate proposed for current inventory is \$33,650.
- The County has made significant strides to reduce printing, which can be seen in the reduction of mono images per year.
 - Roughly 2.5M fewer mono images per year.
