

RESOLUTION NO. 24-001

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZE THE CEO / DIRECTOR OF EMERGENCY SERVICES, SHERIFF-CORONER / ASSISTANT DIRECTOR OF EMERGENCY SERVICES, AND/OR THE UNDERSHERIFF TO EXECUTE FOR, AND ON BEHALF OF, MENDOCINO COUNTY ANY ACTIONS NECESSARY FOR THE ADMINISTRATION OF THE STATE HOMELAND SECURITY GRANT PROGRAM (FY23) AND THE EMERGENCY MANAGEMENT PERFORMANCE GRANT (FY23)

WHEREAS, Mendocino County Code Chapter 7.04 (adopted by Ordinance No. 4366) establishes the Mendocino County Operational Area; and

WHEREAS, Mendocino County Office of Emergency Services is defined by that ordinance as the emergency organization coordinating the emergency functions of this County; and

WHEREAS, for the past several years, Mendocino County has been awarded the Federal Department of Homeland Security Grants for the State Homeland Security Grant Program, the Emergency Management Performance Grant, and the Emergency Management Performance Supplemental Grant; and

WHEREAS, the State Homeland Security Grant, the Emergency Management Performance Grant, and the Emergency Management Performance Supplemental Grant requires a certified copy of the Board of Supervisors Resolution appointing agents authorized to execute any actions necessary under these grants for Fiscal Year 2023.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors authorizes the CEO / Director of Emergency Services, Sheriff-Coroner / Assistant Director of Emergency Services, and/or Undersheriff to execute for, and on behalf of Mendocino County any actions necessary for the administration of the State Homeland Security Grant (FY23), and the Emergency Management Performance Grant (FY23); approves the Resolution to be submitted with each grant application; and authorizes the Chair to sign their name.
