AMENDMENT NUMBER 2 TO DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 200084 WITH EEGER BEEVER TREE SERVICE, INC., FOR VEGETATION MANAGEMENT SERVICES FOR CASPAR LANDFILL

This Amendment Number (No.) 2 to Department of Transportation (DOT) Agreement No. 200084 is entered into this 20th day of June , 2023, by and between the County of Mendocino, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Eeger Beever Tree Service, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, DOT Agreement No. 200084 was entered into on June 8, 2021, for vegetation management services for Caspar Landfill; and

WHEREAS, Amendment No. 1 to DOT Agreement No. 200084/Purchasing Agent Agreement No. 22-60 was entered into on April 29, 2022; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in DOT Agreement No. 200084, as amended, from July 31, 2023 to July 31, 2024; and

WHEREAS, additional funds are needed to perform the vegetation management services for an additional year.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in DOT Agreement No. 200084, as amended, will be extended from July 31, 2023 to July 31, 2024.
- 2. The total not-to-exceed compensation payable to the contractor is increased by \$22,400 to a revised not-to-exceed amount of \$67,200

All other terms and conditions of DOT Agreement No. <u>200084</u> shall remain in full force and effect.
