RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 25-111 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, the County job classifications listed in Attachment A have been determined to be dormant by the Human Resources Department; and

WHEREAS, there are no current positions or incumbents allocated to the classifications listed in Attachment A; and

WHEREAS, the Civil Service Commission, at its October 15, 2025 public meeting, approved the abolishment of dormant Civil Service classifications listed in Attachment A; and

WHEREAS, Human Resources has fulfilled its obligations with affected bargaining units under Myers-Milia Brown Act (MMBA).

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby authorize the abolishment of dormant classifications listed in Attachment A, or as amended by the Board.

The effective date of this Resolution shall be November 9, 2025, to coincide with the beginning of Pay Period 24-25.
