THIRD AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 21-165

This Third Amendment to BOS Agreement No. 21-165 is entered into this __7th__ day of __February___, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Abbott & Kindermann, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-165 was entered into on September 15, 2021; and

WHEREAS, BOS Agreement No. <u>21-165-A1</u> was entered into on <u>April 5, 2022</u>, extending the termination date from June 30, 2022, to December 31, 2022, and increasing the total amount set out in the original BOS Agreement No. 21-165 from \$10,000 to \$20,000; and

WHEREAS, BOS Agreement No. 21-165-A2 was entered into on August 16, 2022; inceasing the total amount from \$20,000 to \$45,000; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Abbott & Kindermann, Inc., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date from December 31, 2022 to December 31, 2023.

NOW, THEREFORE, we agree as follows:

1. The terminate date shall be extended from December 31, 2022 to December 31, 2023.

All other terms and conditions of BOS Agreement No. <u>21-165</u>, as amended by Agreement No. 21-165-A2, shall remain in full force and effect.
