**A RESOLUTION TO THE MENDOCINO COUNTY BOARD OF SUPERVISORS
REQUESTING PERMISSION FOR THE ROUND VALLEY INDIAN TRIBES'
CALIFORNIA INDIAN DAYS PARADE IN COVELO, CALIFORNIA ON
SEPTEMBER 28, 2019**

WHEREAS, the Round Valley Indian Tribes are the sovereign Tribal Nation of the Indian Tribes of the Round Valley Indian Reservation, and

WHEREAS, the Round Valley Tribal Council is recognized by the Federal Government of the United States of America as the governing body for the Indians of the Reservation, and

WHEREAS, Article V, Section 1 of the Constitution of the Round Valley Indian Tribes authorizes the Round Valley Tribal Council to administer all Tribal Business, and

WHEREAS, over the past years the Round Valley Indian Tribes hosts the California Indian Days celebration which is held in September each and every year since it became a recognized holiday, and

WHEREAS, the Round Valley Tribal Council wishes to hold a parade in connection with the California Indian Days celebration, and

WHEREAS, said parade will be held on September 28, 2019 between 9:00 a.m. and 12:00 Noon (line up for the parade and actual parade) commencing on Main Street and continuing on through Highway 162 through the town of Covelo and ending at Hidden Oaks Park off Highway 162, and

WHEREAS, in order for the parade to be held the Round Valley Indian Tribes need to seek permission from the Mendocino County Board of Supervisors for permission pursuant to the Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on state Conventional Highway Right of Ways to conduct a parade.

NOW THEREFORE BE IT RESOLVED, that the Round Valley Tribal Council is hereby requesting the Mendocino County Board of Supervisors to grant the Round Valley Indian Tribes permission for the California Indian Days Parade to be held in Covelo, California 95428 on September 28, 2019.

BE IT FURTHER RESOLVED, that the President of the Round Valley Tribal Council, and/or the Vice-President in the absence of the President is hereby authorized by the governing body to execute said resolution, applications, permits, and/or agreements to carry out the intent of said resolution to host a parade on California Indian Days on September 28, 2019.


