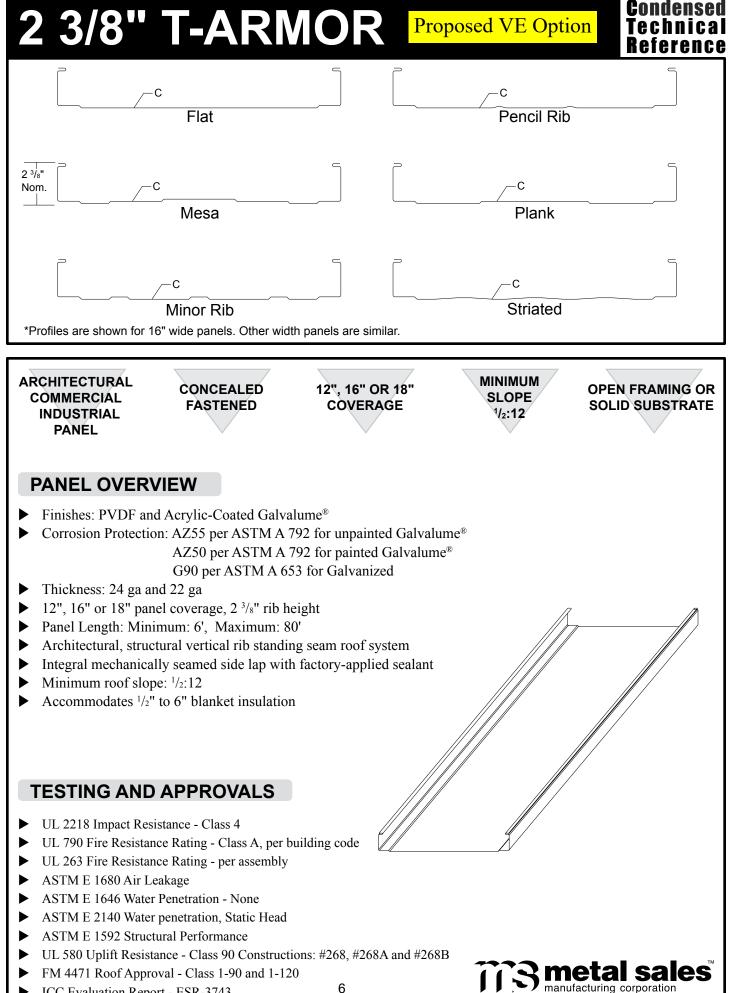

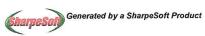

VE Option #4 - Remove Lighting Fixture Battery Back-Up This change removed the rededundant batteries included in the fixtures because they are all backed up by the lighting inverter

VE Option #7 - Change M580 hot standby to M340 PLC The existing facility uses a Modicon M340 PLC, and the M340 is used in many jails without issue. We typically use the M580 in large facilities where the total load on the PLC exceeds the capabilities of the M340.
