

**RESOLUTION NO. 26-005**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS SITTING AS THE MENDOCINO COUNTY AIR QUALITY MANAGEMENT DISTRICT BOARD AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO, AS TO POSITIONS ALLOCATED TO THE AIR QUALITY MANAGEMENT DISTRICT**

WHEREAS, the Board of Supervisors has adopted Resolution No. 25-111 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the desire of the Board of Supervisors sitting as the Mendocino County Air Quality Management District Board to amend said resolution as to positions allocated to the Mendocino County Air Quality Management District ("District") to meet the needs of the District; and

WHEREAS, the District has agreed to incorporate the positions below within their existing fiscal year budgets; and

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors sitting as the Mendocino County Air Quality Management District Board hereby authorize the Position Allocation Table, as to positions allocated to the District, of said Resolution to be amended as follows:
