## AMENDMENT TO COUNTY OF MENDOCINO PURCHASING AGENT AGREEMENT NO. 20-133

This Amendment to Agreement No. <u>PA 20-133</u> is entered into this **6th** day of **June**, 2023, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>Chapel by the Sea</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 20-133 was entered into on June 10, 2020; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. <u>PA 20-133</u>, from <u>June 30</u>, 2023 to <u>June 30</u>, 2024; and

WHEREAS, Agreement No. PA 20-133 provided for an option to extend the Agreement for up to two (2) consecutive one (1) year periods; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in the original Agreement No  $\underline{PA}$  20-133 by \$16,666.66 for a new total contract amount of \$66,666.66.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original Agreement No. PA 20-133 will be extended from June 30, 2023 to June 30, 2024.
- 2. The amount set out in Agreement No. <u>PA 20-133</u> will be increased by \$16,666.66, the maximum amount of the first one-year extension.
- 3. The Payment Terms, Exhibit B, Item No. 3 set out in original Agreement No. <u>PA 20-133</u> has been altered and a new Payment Terms, Exhibit B is attached herein with changes denoted in bold font.

All other terms and conditions of Agreement No. PA 20-133 shall remain in full force and effect.

Special Transportation of remains over 10 miles or to mortuary in Ukiah for examination	\$200.00 per case
Standby time in excess of 1 hour	\$20.00 per hour

3. Payments under this Agreement shall not exceed Sixty-Six Thousand Six Hundred Sixty-Six Dollars and Sixty-Six Cents (\$66,666.66) for the term of this Agreement.
