## ORDINANCE OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS REPEALING CHAPTER 2.39, "PUBLIC SAFETY ADVISORY BOARD" OF THE MENDOCINO COUNTY CODE

WHEREAS, the Mendocino County Board of Supervisors directed the County Counsel to return to the Board of Supervisors with the necessary actions to dissolve the Public Safety Advisory Board.

NOW, THEREFORE, the Mendocino County Board of Supervisors does hereby ordain as follows:

<u>Section 1:</u> Chapter 2.39 of the Mendocino County Code, including sections 2.39.010 through 2.39.06, inclusive, are hereby repealed.

<u>Section 2:</u> <u>Environmental Determination.</u> Adoption of this Ordinance is exempt from the provisions of the California Environmental Quality Act (Public Resources Code Section 21000 *et seq.*; "CEQA") pursuant to the following: Public Resource Code Section 15061 provides that activity is covered by the common sense exemption that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. Here, this Ordinance merely dissolves the Public Safety Advisory Board.

<u>Section 3:</u> <u>Severability.</u> If any section, subsection, sentence, clause phrase, or portion of this ordinance is for any reason held invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause, and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid or unconstitutional.

**Section 4. Effective Date.** This ordinance shall be effective thirty (30) days after its adoption.
