**THIRD AMENDMENT TO COUNTY OF MENDOCINO  
AGREEMENT NO. BOS-17-100**

This Third Amendment to Agreement No. BOS-17-100 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **COBBLESTONE SYSTEMS CORP.**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-17-100 was entered into on September 12, 2017 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. BOS-17-100 was entered into on February 6, 2018 (the "First Amendment") changing user licenses from "Named User" to "Concurrent User"; and

WHEREAS, Second Amendment to Agreement No. BOS-17-100 was entered into on April 5, 2022 (the "Second Amendment") extending the term through September 30, 2024 and increasing the amount by \$57,004.35, from \$64,467.92 to \$121,472.27; and

WHEREAS, the Initial Agreement, First Amendment, and Second Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this Third Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from September 30, 2024 to September 30, 2027; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$40,207.37, from 121,472.27 to \$161,679.64, as more specifically provided in Exhibit A of this Third Amendment, attached hereto and incorporated herein by reference.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from September 30, 2024 to September 30, 2027.

2. The total contracted amount set out in the Agreement is hereby increased by \$40,207.37, from 121,472.27 to \$161,679.64, as more specifically provided in Exhibit A, which shows terms and pricing for the 2024-2027 renewals.

All other terms and conditions of the Agreement shall remain in full force and effect.
