RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 22-149 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, the Board of Supervisors has adopted Resolution No. 22-221 on November 1, 2022, and

WHEREAS, the deletion of 1.0 FTE Staff Assistant II-Conf from Executive Office-Health Benefits budget unit 1020 is errantly designated and the correct designation is Health Benefits budget unit 0715; and

WHEREAS, the deletion of 2.0 FTE Staff Assistant III from budget unit 4013 is errantly designated; and the correct designation is deletion of 1.0 FTE Staff Assistant II from budget unit 4013; and

WHEREAS, the deletion of 1.0 FTE Supervising Staff Assistant from budget unit 4050 (PN3632-vacant) is errantly stated and the correct PN is 3075; and

WHEREAS, the deletion of 1.0 FTE Staff Assistant II from budget unit 4052 is errantly stated and the correct FTE is 0.25; and

WHEREAS, the additions to Mental Health – Treatment Act – Measure B budget unit 4050 is errantly named and the correct name is Mental Health budget unit 4050; and

WHEREAS, the addition of 1.0 FTE Program Administrator to budget unit Mental Health – Treatment Act – Measure B budget unit 4052 is errantly designated and the correct designation is Mental Health budget unit 4050; and

WHEREAS, it is the desire of the Board of Supervisors to amend Resolution No. 22-221 to meet the needs of County service.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby adopts Resolution correcting No. 22-221.

The effective date of this Resolution shall be retroactive to November 13, 2022, to coincide with the beginning of Pay Period 24-22.
